**Day stalls:** All stalls are permanent box with doors. ***Stalls must be requested ahead*** and paid with entry fees. Please call ahead to check availability. Stalls will either be in large barn, or shed row adjacent to new hay barn. Bedding provided. Additional bedding \$7.50 per bag.

**Dogs:** Allowed on leash and in hand only. No retractable leashes please.

**Coggins:** Negative coggins required on all horses, please include copy with entry form.

**Arenas:** Outdoor accommodates large dressage arena with warm up around perimeter. This arena will be used for all warm ups prior to Second Level rides.

Indoor arena is 160' X 60' and will be used for training thru First Level. Both arenas have professional grade "Lightfoot" footing which is a combination sand, material and rubber.

In case of severe weather, warm up time will be given in the indoor prior to divisions and or/rides. Second Level will be moved to the indoor arena.

**Ribbons** awarded 1st-6th place. High Point awarded for High Scoring Jr. and High Score in Training Level Tests 1-4.
